All traffic control will be the responsibility of the contractor, and must comply with all CDOT and MUTCD standards.
- 6. No work in or use of the public right of way is to be done when a special event is taking place. It is up to the applicant to determine if an event is scheduled. To obtain a listing of programs or events within the City of Chicago please dial 311 when you are within the City boundaries.
- 7. A copy of the permit must remain on-site for inspector's review.
