Please review Municipal Code of Chicago § 10-21 and the Excavator Handbook (posted on 811 Chicago's website) for additional information related to Chicago's one-call regulations, including outlining the dig site, extending dig tickets, and remarking work sites.
- 2. A copy of the permit must remain on-site 24 hours per day for inspector's review. Posting a copy on barricades is acceptable.

- 4. At least 3 of 4 corners at any intersection must be accessible at all times
- 5. No work in or use of the public right of way is to be done when a special event is taking place. It is up to the applicant to determine if an event is scheduled. To obtain a listing of programs or events within the City of Chicago, please dial 311 when you are within the City boundaries.
- Contractor, sub-contractor or the entity performing the work shall remove all temporary parking restriction signs upon completion of the work
- 7. If Non-Residential Street is Outside the CBD, then START no earlier than 9:00 A.M. and END no later than 4:00 P.M.
- If Residential Street is Outside the CBD, then START no earlier than 7:00 A.M. and END no later than 3:00 P.M.
- All work shall be in accordance with CDOT Rules and Regulations for Construction in the Public Way and City of Chicago Municipal Code. Work to be performed as per plans and specifications. All traffic control will be the responsibility of the contractor, and must comply with all CDOT and MUTCD standards.

- 10. Contractor must secure plating over all openings in the roadway and secure all sidewalk/parkway openings during non-working hours until such time when the road surface is restored.
