All traffic control will be the responsibility of the contractor, and must comply with all CDOT and MUTCD standards.
- 10. Pedestrian walkway must be kept free of all obstructions and debris.
- 11. For Operating Equipment and Park Work Vehicles, if Non-Residential Street is outside the CBD, then START no earlier than 9:00 A.M. and END no later than 4:00 P.M. or 7:00 PM to 6:00 AM.
- 12. No work in or use of the public right of way is to be done when a special event is taking place. It is up to the applicant to determine if an event is scheduled. To obtain a listing of programs or events within the City of Chicago please dial 311 when you are within the City boundaries.
- 13. Unless specifically permitted to do so, permittees shall not impede bike lanes in any manner during site visits or as part of construction activities.
